

Chris Bryson


Higher Education

Agricultural Policy



Alumni Spotlight



Dr. Elizabeth Smith

After graduating from the PUBP program with a specialization in P-20 Education in December 2016, Dr. Smith entered into a leadership role for the Teachers Institute for Tulsa – a partnership in Tulsa, OK between the University of Tulsa (TU), Yale University, and Tulsa Public Schools.

In this position, she collaborated with TU and Yale faculty and administrators to implement the Yale National Initiative in the city, which created and provided in-depth content-focused seminars for Tulsa teachers. During this same year, she was also selected as a member of a small, worldwide cohort of faculty members and assessment leaders through the Assessment Leadership Institute.

Then in Fall 2017, Dr. Smith received the Best Paper Award for one of her dissertation papers at the Annual Meeting of the Rocky Mountain Educational Research Association -- and thereafter began her new position at TU as an assistant professor and chair of its Department of Education.

In addition to her published research surrounding the role faculty play in assessment and school-university partnerships, her education policy course teachings, and her service duties as a faculty member, Dr. Smith also works to build relationships with teachers, administrators, policymakers, and legislators throughout the state of Oklahoma to form a broad partnership to improve its education system.

A published researcher on assessment practices in higher education and school-university partnerships, Dr. Smith uses the interdisciplinary research and policy analysis skills she developed while in the PUBP program to influence Oklahoma's education policy by writing for the Oklahoma Policy Institute and the *Tulsa World* to reach legislators, policymakers, and the public.

Dr. Smith also attributes her choice to broaden her knowledge of education to the opportunities she had in the PUBP program to learn from faculty in different fields and to collaborate with fellow students interested in other types of policy. Because of these experiences, she now seeks to teach her students not only about education policy, but also about its connection to policies on housing, health, and economic security. "If not for having that modeled through the PUBP program," she states, "I am not sure I would have thought this way."

In Focus: Faculty-Student Collaboration

Eric Button and Dr. William Schreckhise

Second semester PUBP student Eric Button began his research on veterans' policy while taking Dr. Schreckhise's American Political Institutions course during his first semester in the Political Science M.A. program.

Finding a similar interest in studying the development of veterans' treatment courts (VTCs), or alternative courts of law that focus on criminal cases involving military veterans as defendants, the two began their research into the diffusion of these specialized courts across the U.S.

Utilizing random-effects parametric survival modeling to examine the diffusion of VTCs from 2004 to 2014, the authors found that, despite previous expectations, an individual state's political orientation does not predict

adoption. States dominated by Republicans were no more likely to adopt VTCs than those led by Democrats. They argue that this null finding could be directly attributed to a fairly favorable social construction of veterans across the states.

Of the factors that do matter for VTCs to diffuse successfully, Button and Schreckhise identified 1) the proportion of veterans and 2) the financial returns on VTC investments as highly important.

The authors argue that more research needs to be done into conditions favorable to both creating and maintaining successful VTCs. Button and Schreckhise hope their work will contribute to this area of research, which is largely dominated by local and regional case

studies that only gauge program efficacy.

Through a diffusion analysis approach, the authors hope they can assist state-level policymakers in their decisions about adopting their own VTCs - a choice that the authors argue results in both social and economic benefits for their communities.
